CHINA TOURIST VISA

Single and Double Entries Visa

Document required:

1. Original passport with valid Hong Kong entry stamp / landing slip
or Original passport with valid Hong Kong working / stay permit or copy of Hong Kong Identity Card
(passport must have two blank pages available to stamp the visa and the passport with validity of at least 6 months from the date of visa application)
2. One recent passport size photo (white background, front facing, no smiling face, no ear rings on, no necklace and no glasses on)

6 Months Multiple Entries Visa

Document required:

1. Original passport (passport must have two blank pages available to stamp the visa and the passport with validity of at least 8 months from the date of visa application)
2. One recent passport size photo (white background, front facing, no smiling face, no ear rings on, no necklace and no glasses on)
3. Copy of Hong Kong Identity Card
4. Valid Hong Kong working / stay permit must be over 7 months & shown in the passport (not applicable for first time application)

1-Year Multiple Entries Visa

Document required:

1. Original passport (passport must have two blank pages available to stamp the visa and the passport with validity of at least 14 months beyond the date of application)
2. One recent passport size photo (white background, front facing, no smiling face, no ear rings on, no necklace and no glasses on)
3. Copy of Hong Kong Identity Card
4. Valid Hong Kong working / stay permit must be over 13 months & shown in the passport (not applicable for first time application)

3-Year Multiple Entries Visa (for HK Permanent ID holder only)

Document required:

1. Original passport (passport must have two blank pages available to stamp the visa and the passport with validity of at least 38 months from the date of visa application)
2. One recent passport size photo (white background, front facing, no smiling face, no ear rings on, no necklace and no glasses on)
3. Copy of Hong Kong Permanent Identity Card & prove of 6 months or above multiple visa applied before (not applicable for first time application).

Additional requirement for Business Visa: Company Name Card (Business card), Invitation Letter & Business Registration Certificate from Company in China.

* Passport issued in or after 2015, the old passport need to present upon visa application **
